GENERAL INSTRUCTIONS

The MFJ-1905 are feet designed to work with tripod that have 1-1/4 legs. They secure at the bottom of each leg using a 1/4-20 nut and bolt. The larger size MFJ tripods have this hole pre-drilled under the rubber foot of each leg. Attach the foot to each leg as shown in the image with the long side facing outward. Make sure the bolts are loose enough to allow the foot to swivel up over the leg when not in use. The bolts need not be tights as the nylon lock will prevent the nut from coming off. If your tripod does not have pre-drilled holes then you will need to drill a 1/4 hole ½ inch from the bottom of the leg. Make sure you drill the hole so that the leg will lay flat on the ground when installed.



Use good judgement when deciding how high you intend to extend the mast, and how large an antenna you plan to put at the top of it. Although the tripod may support the load without guys, sudden gust of wind can cause the system to tip over if it is not secured with guy wires. Any load that extends beyond the radius of the legs can tip the tripod over.

Never place the tripod near power lines or people. Always place it in an open area where if it fell, there would be no danger to anyone or anything.



Holes are provided in the feet to allow for stakes to be driven into the ground through the feet. Driving the stake at a 90 degree angle with the leg will increase the holding power of the stake If the tripod tries to tip, the leg in the opposite direction will be lifted straight up. A rod driven at an angle will be harder to lift.
